

Terms & Conditions

All reservations and agreements of events are made upon and are subject to the rules and regulations of the hotel and the following conditions.

PROVISIONAL BOOKING: A booking will be held by the hotel for 14 days after which a deposit of €1000 is required to confirm and secure the booking along with terms & condition signed by both Bride & Groom. This is non-refundable. If the booking is not secured at this time it may be released without prior notice. All Weddings must be booked nine months in advance and dates are subject to availability. We reserve the right to cancel any function without obligation and to refund any deposit and cancel a function booked under false pretence or by a third party.

MINIMUM NUMBERS: Please note minimum numbers of 100 are required in order to receive the full complimentary package

Should you wish to avail of a bar extension please advise 3months in advance so an application may be made to the Courts. The current cost of a bar extension (incl fees) is €250 payable by the Bride & Groom

All musical entertainment must finish by 1.30am

PAYMENT: Full payment will be required the week before the function by bank draft or cash.

MENU SELECTION AND TASTING: All menus must be selected at least 4 weeks prior to the wedding date. Each couple will be invited to a tasting in the restaurant on an evening between Sunday and Thursday prior to their wedding date. This tasting allows any changes required to the meal chosen for your day. The tasting for the couple is complimentary but not inclusive of wines.

APPROX. INCREASE OF COSTS: The quotation of all food, beverages, accommodation etc. herein is subject to proportionate increase (approx 5% per annum) from the time of brochure print, Jan 2008. This increase is allowed in order to meet increased costs of foods and beverages and other costs of operation existing at the time of performance of our undertaking by reason of increasing present commodity prices, labour costs, taxes or currency values. Patrons expressly grant the right to the hotel to increase prices herein quoted or to make reasonable substitutions on the menu and agree to pay such increased prices and to accept such substitutions.

No food or beverages of any kind will be permitted to be brought into the hotel by the patron or any of the patron's guests or invitees from outside the hotel with the exception of the wedding cake.

Final Numbers must be supplied to the Hotel 72hours in advance – this will be the minimum numbers charged for.

The hotel will not accept responsibility for any goods lost, damaged or stolen, while on the premises

All fire exits must be kept clear from obstructions. Instructions of security and management regarding same must be adhered to.

The organiser will be responsible for the conduct and discipline of all persons attending the event solely excepting the hotel staff

All weddings must be booked nine months in advance prior to the event, please speak with the Wedding team should you have any dates within the 9 month period.

All wedding bookings must be made in person by the Bride and Groom.

The included menus and prices are conditional to a minimum of 5 courses to include tea and coffee. All prices are subject to change.

10% discount is available to bookings made mid week Sunday to Thursdays inclusive.
